Future was originally established by the Future Group in 1996. In the January of 2003, Future Computers was purchased by Quita Barron and Andrew Bischof making it 100% locally owned and operated.

Quita had been managing Future Computers for five years prior to purchasing it and was previously employed by Mita Copiers Australia for ten years in the capacity of Service Controller and Administration Manager. Having such a strong service background has enabled the focus of the Cairns office to swing from the old ideals of box moving to a solid and reliable service company.

Andrew comes from a technical background in mechanics and auto electrics as well as owning his own repair and service company.

Both originally from Melbourne, they have the skills that come with that "Big City Mentality" but compliment this with knowing how important personal relationships are in a town the size of Cairns.

It is this experience and knowledge of what is required for a service department to run correctly, as well as a clear understanding of the importance of professional service that has shaped the culture of Future Computers to become one of the premier IT companies in Cairns.

A good example of this is the balance of staff at Future, with the Service Department having seven staff, whilst the sales/admin department has just four, including Andrew and Quita.

In October 1996 Future became a Toshiba Business Partner and later followed in August 2000 with a business partnership with IBM/Lenovo. Due to the continuing growth of Future into larger and more mission critical sites, it was felt a "Tier One" product to supply and of course support was needed.

Toshiba and IBM/Lenovo have shown strong commitment to Future, this has seen Future become involved in supplying and supporting an increasing number of larger and more complex installations.
